Also in March, as a result of all your hard work on fundraising projects, Jayne Owiesny, our Foundation Treasurer, has been busy writing donation checks to each of the organizations identified in our 2018-2019 budget (found on page 11 of your Member Handbook). The vast majority of donations from our Club have been delivered. The remaining funds will be disbursed at the proper time (i.e., scholarships). Due to our fundraising success, the board has approved increasing our Germanna Community College and Orange County High School scholarships to \$1,500 each. We will also add a fourth Germanna Scholorship.

SECRETARY'S REPORT: The minutes of the February 28, 2019 meeting, which were previously distributed, were amended to reflect the change in the number of new member inducted this year from 12 to 10. Motion made by Ann Walker and seconded by Jayne Owiesny to accept the minutes as corrected.

TREASURER'S REPORT: Jayne Owiesny

- The Foundation budget report was accepted for audit.

PRESIDENT'S REPORT: Linda Shnayer

- We voted to increase all scholarships, Orange County High School and Germanna College, to \$1,500. Lake of the Woods Lioness Lions Club CONFLICT OF INTEREST POLICY

Considering the Club's accountability to its membership and the public, the Board of Directors adopts the following policy and procedures with respect to disclosure requirements concerning transactions and relationships that may involve potential conflict of interest.

- Each officer, and director shall avoid situations where their personal interest could conflict with, or appear to conflict with, the interest of the Club.
- The use of Club's assets for any unlawful or improper purpose is strictly prohibited.
- No undisclosed or unrecorded asset is to be established for any purpose.
- No false entries are to be made in the books for any reasons, and no member or Director shall engage
 in any arrangement that results in such prohibited act.
- No payments are to be approved or made with the intention that any part is to be used for any purpose other than that described in the supporting documents.
- Any board member who knows of any unrecorded asset or any prohibited act must promptly report it to the total board of the Club.
- This policy requires the annual submission from Lake of the Woods Lioness Lions Club board members, of a statement certifying their compliance with the policy. The association's Officers are responsible for review and enforcement of this policy. Should Board Members believe that a conflict may exist in the performance of their fiduciary duties they must disclose such conflict and notify all officers. All disclosure statements will be reviewed by the officers and submitted to the full board for final analysis and action.
- This policy shall also apply to the Lake of the Woods Lioness Lions Foundation Board of Directors.

- Each officer, and director shall avoid situations where their personal interest could conflict with, or appear to conflict with, the interest of the Club.
- The use of Club's assets for any unlawful or improper purpose is strictly prohibited.
- No undisclosed or unrecorded asset is to be established for any purpose.
- No false entries are to be made in the books for any reasons, and no member or Director shall engage in any arrangement that results in such prohibited act.
- No payments are to be approved or made with the intention that any part is to be used for any purpose other than that described in the supporting documents.
- Any board member who knows of any unrecorded asset or any prohibited act must promptly report it to the total board of the Club.
- This policy requires the annual submission from Lake of the Woods Lioness Lions Club board members, of a statement certifying their compliance with the policy. The association's Officers are responsible for review and enforcement of this policy. Should Board Members believe that a conflict may exist in the performance of their fiduciary duties they must disclose such conflict and notify all officers. All disclosure statements will be reviewed by the officers and submitted to the full board for final analysis and action.

Author! Author! Writing plays a big part in Julie's life. Not only is she a published author, more on that later, but she is one of the founding members of the Lake of the Woods (LOW), Lake Author's Club. Serving on the Steering Committee for many years, Julie just wrapped up that role as she felt it was time to make room for some new faces.

Born and raised in Wausau ("far away place"), Wisconsin, Julie took a circuitous route to arrive here at the Lake. She met her h



took a circuitous route to arrive here at the Lake. She met her husband Jack when she attended college in Valparaiso, Indiana. Graduating from Valparaiso University with a Bachelors degree in English and Theater and later University of Wisconsin-Madison with a Master's in Curriculum and Instruction, Julie became a teacher. A drama coach for 8th graders, Julie taught at the middle school level for almost her entire career, writing and producing plays and adaptations. Retiring from teaching early in 2005 (she got an offer she couldn't refuse!) she promptly accompanied Jack on a semester-long teaching gig in London and never looked back. While in London, Julie was able to do research for her second book. Upon returning to the states she did something that she loves, tutoring, for a number of years.

Julie and Jack have two children, daughter Jennifer and her husband Steve and granddaughters Ella and Mia, who live in Richmond, and son Nick and wife Whitney, who with children Ben and Ruby live in Tacoma Park, MD. Moving here from Naperville, Illinois, Julie and Jack first stayed with their daughter, who then lived in Springfield, VA, where they got the full experience of Snowmageddon (the horrendous snow storm experienced by this and other areas in 2010). Welcome to the East Coast!

Arriving in Lake of the Woods in spring of 2010, they moved into their home which was picked, in part, as it offered a first floor office for Julie to write. Her books bring history to life. To date she has published <u>D-Day and Beyond: A True Story of Escape and POW Survival and The First 150 Years: A History of the Naperville Municipal Band</u>, co-written with by Ron Keller. Julie has been on the go at the Lake, not only in the author's club but supporting Lioness initiatives such as the Holiday House walk. Last year she completed two years as co-chair of Membership with Joyce Morlan. While Jack is deeply involved with Civil War activities at the Lake, Julie is hard at work on new manuscripts. An active member of the Society for Children's Book Writers, she is currently working on a book for middle grade readers. She teaches writing classes and tutors in writing, does editing on the side, and offers lively presentations to schools, book clubs, and veterans' organizations about WWII and memoir writing.

Julie is enjoying taking walks with Duke and having adventures as this energetic adoptee learns the Phend household routine.
