Minutes from the December 2, 2010 Lioness BOD Meeting

Attending were Lioness board members Mary Altman, Karen Cakouros, Marge Howard, Marti Martin, Jean McLallen, Linda Ogletree, Zoila Ortega, Pat See, Ann Walker, Pat Watterworth, Ann Wood, and Barbara York.

Minutes from the October 28, 2010, meeting had been previously distributed, and the Board accepted them as written.

The Treasurer's report was accepted and filed for audit.

President's Report - Marge Howard

- Request for MAL status from Carolyn Gordon, Sharon Kaltenmark and Lourdes DeSanto were received and granted by the Board.
- Other correspondence included a thank-you letter from the principal of the Locust Grove Middle School for our donation of \$400.00 to their library fund; a Charter Night invitation from the Lions of Nelson; a thank -you letter from Orange County TRIAD for our donation of \$100; an informational letter from the Lions Hearing Foundation with levels of giving; a request for future program consideration from the Lions District 24-C Leader Dog Chairperson; and letters of appreciation from the Confroy family and LOW Fire and Rescue for our memorial gifts in memory of James Confroy.
- Inasmuch as the LOW Clubhouse is not available for our January meeting, President Marge Howard asked the Board's opinion as to the advisability of cancelling next month's dinner meeting. Lioness Tamer Karen Cakouros stated that if we held our meeting at the church, the expense to the club would be \$175.00. After a brief discussion, IT WAS MOVED BY Ann Walker and DULY SECONDED by Marti Martin that the January meeting be cancelled. MOTION CARRIED. Furthermore, IT WAS MOVED by Pat See and DULY SECONDED by Karen Cakouros that the \$175.00 saved by cancelling the meeting be donated to Canine Companions for Independence in appreciation of the presentation by Jim Purton at our November dinner meeting. MOTION CARRIED.
- The LOW Fire and Rescue Dinner will be held this Friday, December 3, with 109 attendees, and at that time, President Marge Howard will present a gift from our club of \$1,000

- Approximately 125 Holiday House Tour tickets have been sold to date, with continued sales expected.
- Gift wrapping for Child Help East will take place on December 15 from 10:00 a.m. to 2:00 p.m.

Second Vice President's Report – Marti Martin

On December 8, the Lionesses will hold a holiday party and luncheon for the residents and the committee is requesting a check for \$30.00 as a donation to the volunteer entertainment. Therefore, IT WAS MOVED by Karen Cakouros and DULY SECONDED by Zoila Ortega that a donation of \$30.00 to the Flat Run Ramblers be approved. MOTION CARRIED.
- Concern has been expressed over the fact that advertisements and announcements that do not directly
 relate to the Lioness Club have been distributed on the dining tables. Furthermore, it was pointed out
 that our policy regarding this has been inconsistent. After a brief discussion, it was agreed upon that
 no printed material that is not directly related to LOW Lioness Club business and activities will be permitted on the dinner tables at the monthly membership meetings.
- With respect to publicity, Second Vice President Martin Martin reported that photos and articles regarding our recent contributions to the Locust Grove Middle and Elementary Schools were submitted and published, and First Vice President Zoila Ortega is setting up a photo opportunity for the contribution to Germanna Community College's Nurse Aide Certification Exam Scholarship Program, which was recently established by our club.
- The Wilderness Food Pantry will hold a food drive this Saturday, December 4, from 9:00 a.m. to 12:00 noon, at the LOW Clubhouse lower level parking lot and at the Food Pantry trailer.
- Nine White House ornaments for the year 2005 that were recently uncovered will be sold at our upcoming dinner meeting and at the Holiday House Tour for \$5.00 each.
- Connie Buttimer will make an announcement at our dinner meeting, requesting cookies for the Lake Youth Foundation's "Visit with Santa," to be held on December 18, with a sign-up sheet on the table in the Presidents' Room that evening. Additionally, she is in hopes that the sheriff will be present to conduct the Safe Assure Program, which involves making a CD with a video of each child and obtaining the child's fingerprints.

Directors' Comments

• Lioness Director Barbara York presented a policy statement prepared by the Directors regarding emergency fund allocations. After a brief discussion, IT WAS MOVED by Ann Walker and DULY SEC-ONDED by Pat See that the following policy be adopted and included in our handbook: "Should an emergency arise with an individual or an organization requesting money from the Lioness Benevolence Fund for immediate disbursement, the individual or committee chairperson should contact the President, who only has the authority to disburse monies not to exceed \$100.00. If the request is for more than \$100.00, the President must call an emergency meeting, consisting of the First Vice President and at least three (3) more Board members, forming a quorum, to decide if the request is a valid emergency and if we should disburse the amount requested. If approved by the majority of the quorum, the Treasurer would be notified to disburse the funds." MOTION CARRIED.

• Immediate Past President Pat See was pleased to report that a client of Fred Getty's, husband of Lioness Christine Getty, has donated a substantial number of books for our sale this spring at our annual flea market; everyone was most appreciative of Mr. Getty's referral.

In light of the fact that the Lions have a final deadline of September and inasmuch as we have made repeated verbal and e-mail contact with these members to no avail, it was decided that a final letter asking for their intent be mailed, stating that we appreciate their friendship and past participation, but if we did not receive their membership payment by December 31, 2010, we would regretfully acknowledge that they no longer wish to participate and they would be removed from our membership roster. The Board felt this was fair and appropriate.
