Did you Know — Jean McLallen's Story

Though born in Haddonfield, New Jersey, Jean's heart was anchored in Ocean City, New Jersey in and by the water. From an early age on, summers were spent there on the beach at her grandmother's.

By the time Jean was in the 8th grade, her sister, Dolores, was already in college. Jean had an athletic bent and played field hockey and basketball during her high school years in NJ. One summer she visited a friend on Long Beach Island and became captivated by water skiing, so much so, that when she came home, she announced that she wanted to have her own boat. Her father agreed but told her she'd have to pay for it. Undaunted, the next summer she worked as a waitress on the boardwalk in Ocean City and saved half of the money needed to buy a boat. Her father agreed to match what she had earned and soon after, a 16' outboard motor boat was purchased. Each summer she continued to work so that she could buy the gas needed to ski. From that point on, her life seemed to revolve around either water or finance.

After high school graduation, Jean went to Vassar to pursue a liberal arts education. She continued working in Ocean City at Watson's as a hostess and then became the dining room manager. Later she worked for the manager at The Flanders Hotel. It was an ideal situation living at her grandmother's only a block away from work. She could still enjoy the beach with working hours from 3:30 to 9:30 p.m.

After 2 years at Vassar she decided the hotel business was for her and transferred to Cornell Hotel School in New York where she received a B.S. degree in hotel administration.

Thanks to her boyfriend, she got an interview and landed a job at The Drake Hotel in Chicago. Jean soon became interested in the resident manager at the Drake, Bob McLallen, who also happened to be her boyfriend's boss. They discovered they had mutual friends at Cornell as he had graduated earlier. Just prior to their marriage in September 1965, she squeezed in a trip with her parents to the Middle East.

As a newly married couple, they moved to Youngstown, OH due to Bob's new job change with Arby's corporate office. While there, their first son Rob was born. In '69, they moved to Annandale, VA, a welcomed move from the red smoke of the steel mill and depressed economy of Youngstown. Their second son, Scott was born in '71.

Jean was a stay-at-home Mom and chauffeur until the children were in college and in high school. She spent 10 years as a professional volunteer with the Service League and Junior League of northern VA serving as arrangements chairperson and chairing various fundraisers.

In the meantime, Bob established his own consulting firm and needed a financial manager. Jean served as Secretary/Treasurer until her son Rob took over. This allowed her to pursue meeting planning studies at NOVA. She began a new career lasting 10 years at MCI as video conference coordinator. This led to a variety of responsibilities including financial reporting and meeting and conference planning.

In January 1992, Bob suffered cardiac arrest and was no longer able to work. During Bob's long illness, she was offered and took a position at the Arlington Free Clinic as Office Manager and Director of Finance.

In 1989 they bought property on the small lake in LOW and built their dream log cabin in 2000-2001. Weekends were spent here and Bob was able to have more freedom at the cabin. However, after 11 $\frac{1}{2}$ years in and out of hospitals, Bob passed away in 2003. He lived long enough to see 2 of their 4 grand-children. Jean continued working until 2006. It was a "failed retirement" as she soon received a call from the clinic saying they needed help in special gifts and coordinating a federal grant for construction at the clinic. She finally retired in 2011.

She met Peter Taylor, her neighbor 2 doors down. He too was widowed After hosting a party to get to know her neighbors better, several stayed behind to enjoy a glass of wine on her deck. Peter called soon after to invite her for afternoon tea. They became man and wife a year later in 2007.

Jean became a Lioness in 2007 and continues to serve faithfully on the Finance and Budget committee. Last Spring, I found it difficult to focus on the Lioness budget meeting in her beautiful log "cabin" (more like a lodge) home.
