Minutes from the April 26, 2012, meeting had been previously distributed, and the board accepted them as written.

The Treasurer's report was accepted and filed for audit.

Budget Committee Chairs Jean McLallen and Ann Wood presented the LOW Lioness Club 2012-2013 proposed administrative and benevolence budgets, which will be published in the LOW DOWN for the members to review and pose questions.
