The Insider's View

Minutes from the February 24, 2011 Lioness BOD Meeting

Attending were Lioness Board members Mary Altman, Janet Berge, Donna Crawley, Carol Lee, Marti Martin, Zoila Ortega, Pat See, Michelle Senft (for Linda Ogletree), and Pat Watterworth.

Minutes from the January 27, 2011, meeting had been previously distributed, and the Board accepted them as written.

In the absence of Jean McLallen and Ann Wood, Pat See presented the Treasurers' report, which was accepted and filed for audit.

President's Report – Zoila Ortega (for Marge Howard)

- In President Marge Howard's absence, First Vice President Zoila Ortega reported that she had received two letters from LOW Fire and Rescue regarding the dinner hosted by a group of Lionesses. The letters expressed appreciation for the dinner and the donation from the LOW Lioness Club.
- Other correspondence included a letter from Canine Companions thanking the LOW Lioness Club for its donation to that organization, sent after a presentation by a representative of Canine Companions at a Lioness meeting.
- First Vice President Zoila Ortega also reported that Elaine Sibley is resigning from the Lionesses because she and her husband will be moving to Seattle.

First Vice President's Report - Zoila Ortega

- First Vice President Zoila Ortega reported that the Lions have not yet determined whether they will hold their annual Flea Market in the fall. This information was based on an email from Lois Powell and a sign at the Velona Building.
- Past President Pat See reported that plans are well under way for the Lionesses' spring Flea Market. She added that the Lions have been very helpful with the book sale; their efforts have included providing bookcases for book storage and delivering any books donated at the Velona Building to the Ferris Building.

Second Vice President's Report – Marti Martin

- Second Vice President Marti Martin reported that she had received an email from Betty Beck asking for two volunteers to help with food pickup at Bloom on the first Thursday of each month at 9 a.m.
- A group of Lionesses prepared a soup/chili luncheon for the residents at Germanna Heights February 9. Unfortunately, only a small group of residents showed up for the luncheon. The Germanna Heights Lioness group plans to meet at the end of March to discuss future plans, which might include a craft project in April. The group will consider reducing its visits to Germanna Heights to four times per year.

The Board members also asked her to work with Lioness Linda Ogletree to order pins for new members and new pins for members who have lost theirs.

New Business

First Vice President Zoila Ortega introduced a new way to raise funds, which involves the sale of gift cards that can be used at various restaurants, stores, gas stations, and the like. After a period of discussion, Lioness Pat Watterworth moved that the Lionesses begin a no-monetary-obligation gift card sales program through Great Lakes Scrip Center. Lioness Donna Crawley seconded the motion, which the Board passed. First Vice President Zoila Ortega volunteered to get the program started, and Lioness Donna Crawley offered to assist her; the gift card committee will increase in size as needed. Information about the gift card sales program will be available at the March Lioness meeting.

There being no further business to come before the LOW Lioness Board, the meeting was adjourned.
