Secretary's Report: Minutes were approved as presented. Donalda Lovelace reminded everyone that the November 2015 Board of Directors meeting would be held on the first Thursday in December.

Treasurer's Report: Norma Ervin and Barbara Tomayko presented the financials for the Administrative and Benevolence funds. The reports were accepted and filed for audit. LOW Lions filed 2013 and 2014 and Lioness, Elaine Freeland will be doing 2015.

President's Report:

- · President Maureen Otero received a request from Jan Lemieux indicating that 54 people participated in her bridge classes for a grand total of \$2,180. She would like as in past years to have designated \$1,500 for a college scholarship for a local high school student. In addition, she requested to be placed on MAL status until May. Both requests were approved.
- Lioness Betty Girman contacted President Otero and resigned. Her resignation was accepted with regrets.
- · Kathi Martin received a call from Germanna College indicating that one of the scholarship recipients did not enroll. Emily Slunt, chairperson of the Scholarship Committee will be contacted to obtain further information from the college and student. A decision relative to the funds will be tabled until next meeting.
- Region 24-C Zone 1 will be conducting a Zone meeting in Louisa on November 10th 2015. Donalda Lovelace, Karen Cakouros, Barbara Hernan and Maureen Otero will be attending.

LAKE OF THE WOODS LIONESS CLUB *SPONSORS' RESPONSIBILITIES*

Sponsoring a new Lioness is important in that it helps to maintain the vitality of our club with new perspectives, ideas and enthusiasm. It is a role that should be taken seriously and demands the following responsibilities

- * Accompany the prospective member to two meetings and two activities before her induction.
- * It is the responsibility of the prospective sponsor to make the reservation for the dinner meetings with the Tamers. Whether or not the prospective sponsor pays for the prospective Lioness is a matter to be decided between them. Usually, the sponsor invites the prospect and pays for the first dinner; prospects would pay for subsequent dinners.
- * Introduce her to the club's members and make certain to identify the various officers and their responsibilities.
- * Review the club's Constitution and By-Laws with her.
- * Answer any questions that she may have regarding the operation of the club and its goals.
- * Attend the REQUIRED orientation meeting with her. (The orientation meeting is required by the prospective Lioness, but although every effort to attend on the part of the sponsoring Lioness should be made, in the event of an emergency the sponsor may have a substitute attend.)
- * Review the membership kit that she receives upon induction with her and answer any questions she may have.
- * Remind officers and committee chairs to provide her with assignments which will enable her to become an active Lioness immediately.
- * Call her prior to her first few meetings and offer to accompany her to the meeting.

Did You Know—Barbara York

Barbara Cobleigh was born in West Chesterfield, NH, a small New England village on the Connecticut River. Barbara fondly remembers spending time with her grandparents on their farm, Cobleigh Estate, where she picked blueberries and raspberries. She grew up with her two sisters and one brother. Barbara, whose mother passed away when she was eleven, was raised by her father and nannies. Her lifelong connection with the outdoors began as a child with baseball, sledding and skiing. As a teenager during the Swing era, Barbara loved the foxtrot, swing, waltz, tap, and jitterbug. She attended elementary school in New Hampshire and high school in Brattleboro, VT (the nearest high school). After graduation she went to work for New England Telephone &



Telegraph in Brattleboro where she met Frederick York, who was home on leave from WWII. They were married in 1944 and shortly afterward he left the Marine Corps only to be recalled during the Korean conflict. By this time their children, Jimmy and Theresa, were born. Barbara's first assignment as a military wife was Camp Lejeune, NC. They initially lived in Wilmington, not far from the beach. Adapting well to Marine life, Barbara joined the Wives Club, the bowling league, golf, and the PTA.

The next assignment was Korea. The young family and Freddy's mother drove to California sightseeing along the way. The return to Vermont was a dreary drive for Barbara, her mother-in-law, 6 year-old Jimmy and 3 year-old Theresa – without her husband. After safely returning from Korea, Freddy chose to remain in the Corps and was stationed at the Marine Corps Supply Center in Albany, GA. Again, Barbara became an active member of the Wives Club, PTA, and this time, the Gray Ladies, a volunteer organization at the hospital at Turner AFB where she assisted a doctor. Activities of the Wives Club were similar to those of the Lioness. Barbara was always a model in their fashion shows. After a couple of years, she went to work in the telephone office at the Marine base. Their home was near the Flint River and with a group of friends, who all had power boats, they spent most weekends boating, water skiing and picnicking.

After Freddy was transferred to Headquarters Marine Corps in Arlington, they bought a house in Alexandria, and Barbara went to work at the Pentagon's telephone office. She was soon re-assigned to the office of the Secretary of the Army. Barbara had the opportunity to meet public figures including John Eisenhower, President Johnson and Ava Gabor. However, the most fascinating was Jean McArthur, widow of General McArthur. Barbara served as liaison with Mrs. McArthur leading up to dedication of the McArthur Memorial Corridor in the Pentagon, September 11, 1981.

Barbara remained in Alexandria when her husband transferred to Philadelphia for his last Marine Corps assignment. They bought a lot at LOW in 1967 and camped here every weekend. They had reservations at the Clubhouse each Friday, played golf and took square dance lessons. In 1972 they built a house and moved permanently in 1976. Barbara continued the commute to the Pentagon for 12 years before retiring as private secretary to the Administrative Assistant to the Army Secretary. The Yorks loved living here.

The draw of winter sports continued through Barbara's adult years. Their ski group of 10-12 couples, the Mogul Mushers, traveled to Vermont, Colorado (Vale and Aspen), Utah and Austria (where she won \$3000 in the casino). Their golf group took them to many courses in the Bahamas and throughout the US.

As a Pearl Harbor survivor, Freddy, along with Barbara, were guests of the Marines in 1991 for the 50th anniversary of the attack. A week of organized activities on Oahu was followed by a week of private sight-seeing and relaxation on Maui. Frederick York passed away January 30, 2001.

It's evident that Barbara has lots of strength and is a survivor. After insertion of 3 stents, triple by-pass surgery, a carotid endarterectomy and multiple pacemaker placements, Barbara continues to greet everyone with a beautiful soft-spoken voice and lovely smile.

Barbara was walking her dog in February, when she slipped, fell and broke her right tibia and fibula. After a lengthy recovery she has returned to her bridge games and activities of 'Just Friends', a LOW group of widows and widowers who met at GriefShare and continue to have breakfast every Saturday and enjoy dinner and plays at other times. She continues to be a part of the LOW Church family.

Barbara's daughter, Theresa, who lives near Indianapolis has two daughters, Maria and Marty. Her son, Jimmy, lives in Falmouth and has two sons, Kory and Timothy. There are 4 great grandchildren: Kia, Makaela, Nathanial, and baby, Audrey.

As a charter member of the Lioness Club, Barbara has served the organization well in multiple offices including 1st, 2nd and 3rd Vice President, Director and Tamer.

Barbara, thank you for your 28 years of service to the LOW Lioness Club. We Love You!
